Dear Attorney Puskas:

Please be advised of the following:

The report of Special Counsel – Del Sole Cavanaugh Stroyd LLC – regarding the review of Justice Eakin's personal email communications, dated October 30, 2015, concluded "nothing in the emails reveals illegal activity or conduct that could undermine the sanctity of the judicial process." This conclusion is consistent with a previous report requested by the Supreme Court of Pennsylvania and submitted by Robert L. Beyer, Esquire, of Duane Morris LLP. The emails reviewed by Attorney Beyer were also reviewed by Deputy Attorney General Beemer, now the Attorney General in charge of the Commonwealth of Pennsylvania.

The inquiry and investigation by the JCB into whether Justice Eakin's emails violate the Canons and Rules of Judicial Conduct is now before you. Justice J. Michael Eakin self reported the first time and cooperated in this same matter. He has again made himself available to your office with complete cooperation. He has accepted full responsibility for what he did and did not do and therefore the facts are not in dispute. The JCB is most able to examine each email, individually and collectively, to determine prima facie whether Justice Eakin violated the Canons and Rules of Judicial Conduct and/or the Pennsylvania Constitution.

This investigation is an active concern of the JCB, and of course, Supreme Court Justice Michael Eakin.

The recent and understandable media interest, fueled by many opportunistic driven press conferences, has compromised Justice Eakin. As a sitting Supreme Court Justice he cannot respond, with the limited exception of his public apology.

In addition, the process itself to address and resolve these matters has been questioned with much criticism directed towards the confidential nature of JCB investigations into complaints against judges.

Therefore, to address the concerns raised herein, Justice J. Michael Eakin has asked this office to bring to your attention the following: He is requesting that the JCB forward the allegations under inquiry to the Court of Judicial Discipline. This request is also in the nature of concurring in such a forwarding by the JCB. This request and/or concurrence in the forwarding is not to be deemed an admission to any violation of the Canons, and/or the Pennsylvania Constitution, which is the sole province of the Court of Judicial Discipline. The reason is this entire matter must be addressed in a public forum, with due process afforded to all concerned, including the institutions.

Consistent with the intention herein, please find enclosed the public statement that The Honorable Justice J. Michael Eakin is going to release. A copy of this statement has been forwarded to Attorney James Koval, Director of Communications for AOPC.

We hereby waive any confidentiality that may attach to this writing, if any.

Our intention is to meet with counsel to the Court of Judicial Discipline and request that this matter be addressed at the Court's earliest convenience and availability. There will be no request for delay to bring about much needed closure.

Please accept this letter as my entry of appearance.
