Harrisburg. On Monday, February 13, 2012, the Judicial Conduct Board filed a Petition for Relief with the Court of Judicial Discipline to request that Magisterial District Judge Kelly S. Ballentine be suspended with pay due to the pending felony charges against her. On February 13, 2012, the Pennsylvania Office of Attorney General charged Judge Ballentine by criminal complaint with 3 counts of Conflict of Interest, a felony, 6 counts of Tampering with Public Records or Information, a felony of the third degree and 3 counts of Obstructing Administration of Law or Governmental Function, a misdemeanor of the second degree. The criminal complaint alleges that Judge Ballentine failed to pay fines and costs owed on three summary traffic citations which were issued to her in November, 2010 by Lancaster police. Furthermore, the complaint alleges that on or between December, 2010 and January, 2011, Judge Ballentine used her position as judge to personally access the district justice computer system and dismiss her own traffic citations.

The Board reserves further comment on this matter until such time as the criminal charges against Judge Ballentine are resolved.

PETITION FOR RELIEF

AND NOW, this 13th day of February, 2012, comes the Judicial Conduct Board of the Commonwealth of Pennsylvania, by and through Joseph A. Massa, Jr., Chief Counsel, and Elizabeth A. Flaherty, Assistant Counsel, and files this Petition for Relief, under Rule 701 of the Rules of Procedure for the Court of Judicial Discipline and Rule 13(A) of the Judicial Conduct Board Rules of Procedure, Requesting Interim Suspension With Pay, and avers the following:

- Petitioner is the Judicial Conduct Board (hereinafter referred to as "Board") of the Commonwealth of Pennsylvania. The Board is constituted pursuant to Article V, Section 18(a) of the Pennsylvania Constitution.
- Since January, 2006, Kelly S. Ballentine (Respondent) has continually served as the duly elected Magisterial District Judge for District 02-2-01 in Lancaster County, Pennsylvania.

- 3. On February 13, 2012, the Pennsylvania Office of Attorney General charged Respondent with the following offenses: (1) Restricted Activities Conflict of Interest, 65 Pa.C.S.A. § 1103(a), felony¹ (three counts); (2) Tampering with Public Records or Information, 18 Pa.C.S.A. § 4911(a)(1) (three counts), a felony of the third degree; (3) Tampering with Public Records or Information, 18 Pa.C.S.A. § 4911(a)(3) (three counts), a felony of the third degree; and (4) Obstructing Administration of Law or Other Governmental Function, 18 Pa.C.S.A. § 5101 (three counts), a misdemeanor of the second degree. *See Exhibit A.*
- 5. The Pennsylvania Constitution at Article V, § 18(d)(2) provides the following:

Prior to a hearing, the court may issue an interim order directing the suspension, with or without pay, of any justice, judge or justice of the peace against whom formal charges have been filed with the court by the board or against whom has been filed an indictment or information charging a felony. An interim order under this paragraph shall not be considered a final order from which an appeal may be taken.

(emphasis added).

¹ The criminal complaint charges this offense as a F3. However, 65 Pa.C.S.A. § 1109(a) defines the penalty for 65 Pa.C.S.A. § 1103(a) as follows: "Any person who violates provisions of section 1103(a), (b) and (c) (relating to restricted activities) commits a felony and shall, upon conviction, be sentenced to pay a fine of not more than \$10,000 or to

- 6. The Respondent has been charged with engaging in felonious criminal conduct in violation of the Constitution of this Commonwealth and the Rules Governing the Standards of Conduct of Magisterial District Judges which, *inter alia*, require judges to uphold the integrity of the judiciary and to observe high standards of conduct.
- Public confidence in, and the reputation of, the judiciary has been undermined by the charges against Respondent and will continue to be undermined if the Respondent is permitted to remain on the bench after being charged with the aforementioned violations of the law.
- 8. Based upon the nature of the crimes charged; the relation of the charges to the duties of a judge; the impact on the administration of justice; the harm to the reputation of the system of justice; the harm to public confidence in the judiciary, and the totality of the circumstances, the Board seeks the immediate suspension of Respondent with pay pending final disposition of the criminal prosecution by the

imprisonment for not more than five years, or both."

WHEREFORE, the Board, by and through Joseph A. Massa, Jr., Chief Counsel, and Elizabeth A. Flaherty, Assistant Counsel, respectfully requests that this Honorable Court enter an interim order directing the suspension of Respondent with pay and such other relief as may be deemed appropriate.
